YAT's Board of Directors have appointed Kristina Petrea as Executive Director, Joe Dionisio as Artistic Director, and Jean Isaac as President. The board also announced the appointment of Kerry Tarlov as Vice President, Audrey Gardner as Secretary, and Jamie Keller as Treasurer.

"Our new Executive Director and Artistic Director bring both experience and enthusiasm for the future of the company and we look forward to working with them as we continue to strengthen the YAT community, and grow both our student and actor participation and patronage," said new board Vice President, Kerry Tarlov.

Kristina Petrea, YAT's newest Executive Director, has been with the company for two years as the Operations Manager and has overseen all aspects of YAT. "The awkward boy who doesn't fit in at school. These are the kids that I have truly enjoyed watching transform on stage, production after production," said the newly appointed Kristina Petrea.
